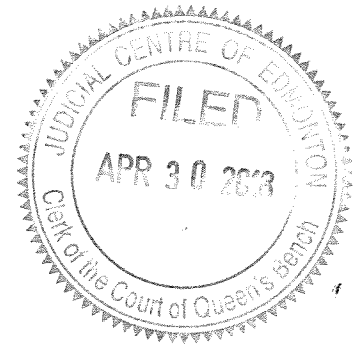



3. The Sawridge Trustees object to produce the records listed in Schedule 2 on the grounds of privilege identified in that Schedule.


