I. SUBMISSIONS

1. Sawridge First Nation ("Sawridge") does not oppose the Application of Priscilla Kennedy ("Ms. Kennedy") for permission to appeal the decision of Case Management Justice Thomas J. dated March 20, 2018. Sawridge submits that, should the Court decide to grant permission to appeal, it would be appropriate that this appeal be expedited and consolidated with the appeal in Sawridge #7, which is scheduled to be heard on June 8, 2018.



Sawridge submits that should permission to appeal be granted, this appeal should be expedited and heard on June 8, 2018 with the appeal of Sawridge #7, in order for the Court of Appeal panel deciding Sawridge #7 to have before it the full scope of Ms. Kennedy's conduct that was at issue before the Case Management Justice.
