**IT IS ORDERED THAT:**

1. The scale of costs applicable to this appeal will be in the discretion of the panel hearing the appeal.
2. Mr. Stoney shall post security for costs in the sum of \$5,000 for each of the two applicants (The Sawridge First Nation and The Trustees).
3. The security (\$10,000 total) must be paid into Court by February 28, 2018, failing which the appeal will be deemed abandoned.
4. Until security is posted, the appeal is stayed.


5. The costs of these applications will be in the cause.

6. Rule 9.4(2)(c) will apply.


