UPON hearing the submissions of counsel for the parties, the Sawridge Trustees, Catherine Twinn, the OPGT, and also hearing the submissions of counsel for the Sawridge First Nation and the "Four Sawridge Trustees" (being Roland Twinn, Bertha L'Hirondelle, Everett Justin Twin and Margaret Ward);

AND UPON reading the Agenda and Plan for Litigation submitted by the Sawridge Trustees on January 3, 2018 ("Agenda"); the written submissions of counsel for the OPGT dated January 4, 2018; and the written submissions of counsel for Catherine Twinn dated January 4, 2018;

IT IS HEREBY ORDERED:

1. The Sawridge Trustees are to draft an Application document in the nature of an originating application that sets out the matters for which advice and direction are

sought. The Sawridge Trustees are to serve this document on Catherine Twinn and the OPGT through their counsel, and post the document on the court ordered website at [www.sawridgetrusts.ca](http://www.sawridgetrusts.ca), and doing so shall constitute proper service.

2. The Sawridge Trustees are to draft a formal Application that sets out their request for advice and directions on such issues as are raised in their Agenda for which they seek this Court's direction.
3. The Application referenced in paragraph #2 need only be served on Catherine Twinn and the OPGT through their counsel, and such service shall constitute proper service of the Application.
4. The parties are to seek the necessary instructions to be prepared to speak to the Application referenced in paragraph #2 at the next case management hearing.
5. This matter is adjourned to a case management meeting to be held on January 19, 2018 at 1:00 p.m., at which time the Application referenced in paragraph #2 above will be heard.


