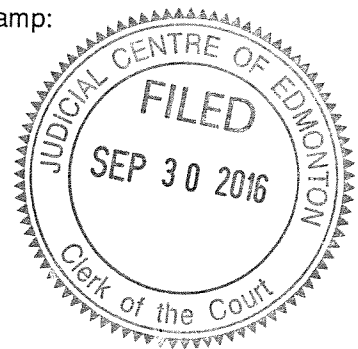




1. I am the Chief Executive Officer of the Sawridge Band *Inter Vivos* Settlement created in 1985 (the "1985 Trust") and as such have personal knowledge of the matters hereinafter deposed to unless stated to be based upon information and belief, in which case I verily believe the same to be true. This Affidavit should be read in conjunction with my Affidavits sworn in this action.

2. There is no genuine issue for hearing with respect to the Application by Maurice Felix Stoney ("Stoney") and his brothers and sisters to be added as parties or intervenors.
3. On or about February 17, 2016, Stoney sought leave to appeal the decision of the Honourable Justice D.R.G. Thomas. Watson, J.A. The Alberta Court of Appeal dismissed Stoney's application for leave to appeal and awarded costs against him to the Sawridge Trustees and the Sawridge First Nation.
4. As of June 14, 2016, Sawridge First Nation is owed \$898.70 plus accrued interest by Stoney. Attached hereto collectively as **Exhibit "A"** to this my Affidavit, are true copies of the Bill of Costs prepared on behalf of Sawridge First Nation pursuant to the order of Watson, J.A. in regards to the aforesaid amount.
5. As of August 25, 2016, the Sawridge Trustees are owed \$858.38 plus accrued interest by Stoney. That amount has since been reduced to \$504.13 further to a set-off of conduct monies payable to Stoney for his attendance at a recent Questioning. Attached hereto collectively as **Exhibit "B"** to this my Affidavit, are true copies of the Bill of Costs prepared on behalf of the Sawridge Trustees pursuant to the order Watson, J.A., as well as the Writ of Enforcement and Status Report filed in regards to the aforesaid amounts.
6. I am advised by Anna Loparco, lawyer of Dentons Canada LLP, solicitor for Sawridge Trustees, Stoney has had costs awarded against him in previous actions against Sawridge First Nation in which Stoney was unsuccessful. He has failed to pay such costs. As an example, attached hereto as **Exhibit "C"** to this my Affidavit, is a true copy of the Personal Property Registry Search Results Report of September 8, 2016, which report outlines a judgment award of October 22, 2014 owed by Stoney to Sawridge First Nation in the amount of \$2,995.65. Also attached hereto as **Exhibit "D"** to this my Affidavit, is a true copy of the Land Title Certificate of September 8, 2016 with the awards registered against Stoney's residence.
7. It is unlikely that the Sawridge Trustees would be able to enforce an Order or Judgment for costs against the assets of Stoney in Alberta.
8. It is unlikely that Stoney would have the ability to pay any costs awards in this Action.
9. Stoney did not file an affidavit as required by the procedural orders granted in 2011 and 2012 in this action.
10. On August 24, 2016, I attended at a case management meeting of parties with the Honourable Mr. Justice Thomas wherein His Lordship indicated that the matter may proceed to trial.
11. I am further advised by Anna Loparco and believe I that the costs of the Application and ultimately, the resolution of the action will be substantial and will be increased if Stoney is permitted to be a party or an intervenor.
12. The 1985 Trust does not have a limitless pool of funds with the ability to fund legal fees for non-feasible interventions such as the one being proposed by Stoney.
13. I do not believe that Stoney is a beneficiary of the 1985 Trust as his family enfranchised and thus according to the 1982 *Indian Act*, Stoney cannot be a member of the Sawridge First Nation and thus cannot be a beneficiary of the 1985 Trust.

14. I make this Affidavit in support of an application for security for costs pursuant to Rule 4.22 of the *Rules of Court* and to oppose making Stoney and his 10 living brothers and sisters parties or intervenors in this action.

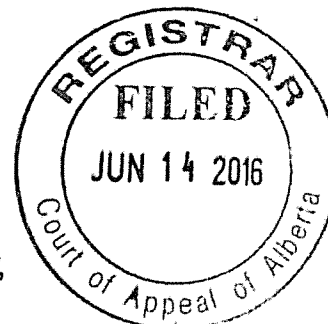
