- I, Paul Bujold, of Edmonton, Alberta make oath and say that:
 - 1. I am the Chief Executive Officer of the 1985 Sawridge Trust and as such have personal knowledge of the matters hereinafter deposed to unless stated to be based upon information and belief, in which case I verily believe the same to be true.
 - 2. I am advised by my counsel that Maurice Stoney filed an appeal of the decision of Justice D.R.G. Thomas dated December 17, 2015, 1985 Sawridge Trust v. Alberta (Public Trustee), 2015 ABQB 799 ("Decision").
 - 3. I am advised by my counsel that the Notice of Appeal filed on behalf of Maurice Stoney was not filed within the required time limits.
 - 4. I attended the case management application on September 2 and 3, 2015 before Justice Thomas that resulted in the Decision and observed that the lawyer for Maurice Stoney, Priscilla Kennedy made no submissions at the application. Attached and marked as Exhibit "A" are the Clerk's notes from the application that show that neither Priscilla Kennedy nor anyone else on behalf of Maurice Stoney made submissions at the application.
 - 5. I am advised by Ed Molstad, solicitor for the Sawridge First Nation, that Mr. Stoney has had costs awards made against him in previous applications against the Sawridge First Nation in which Mr. Stoney was unsuccessful and has failed to pay any such costs.
 - 6. Mr. Stoney is not a member of the Sawridge First Nation and not a beneficiary of the Sawridge Trusts.
 - 7. I make this affidavit to oppose the application for granting an extension of time for Mr. Stoney to file his appeal.
