MOVED by Vera McCoy that the Membership Rules of the Sawridge Indian Band be amended as follows:

See attached Schedule "A".

AMENDMENT TO MEMBERSHIP RULES

NOW THEREFORE BE IT RESOLVED THAT the Rules be and they are hereby amended as follows:

(a) by inserting the following before the period (.) at the end of Section 15:

"and, for greater certainty, no person shall be entitled to have his or her name included in the Band List unless that person has, at some time after July 4, 1985, had a right to have his or her name entered in the Band List pursuant to these Rules."

- (b) by inserting the following provisions as Section 16 and 17:
 - "16. In the event that any of the foregoing provisions of these Rules is held by a court of competent jurisdiction to be invalid in whole or in part on the ground that it is not within the power of the Band to exclude any particular person or persons from membership in the Band, these Rules shall be construed and shall have effect as if contained a specific provision conferring upon each such person a right to have his or her in the Band List but, entered for greater certainty, no other person shall have a right to have his or her name entered or included in the Band List by virtue of the provisions of this Section and, in particular, no person referred to Subsection 11(2) of the Act shall be entitled to membership in the Band otherwise than pursuant to Section 3 of these Rules.
 - 17. In the event that any provision, or part of any provision, of these Rules is held to be invalid or of no binding force or effect by any court of competent jurisdiction, these Rules shall be construed and applied as if such provision or part thereof did not apply to or in the circumstances giving rise to such invalidity and the effect of the remaining provisions, or parts thereof, of these Rules shall not be affected thereby."

NOW THEREFORE BE IT RESOLVED THAT

- 1. the Band hereby consents to, and approves, the assumption by the Band of control of its own membership; and
- the Rules be and they are hereby approved, adopted and established.

SCHEDULE A

- 1. These Rules shall come into force on the day on which the Band gives notice to the Minister pursuant to subsection 10(6) of the Act.
- 2. On and after the day these Rules come into force the Band List of the Band shall be maintained by the Band under the direction and supervision of the Band Council and only those persons whose names are included therein, or who have rights to have their names entered therein, pursuant to these rules shall be members of the Band.
- Each of the following persons shall have a right to have his or her name entered in the Band List;
- (a) any person who, but for the establishment of these rules, would be entitled pursuant to subsection 11(1) of the Act to have his or her name entered in the Band List required to be maintained in the Department and who, at any time after these rules come into force, either
 - (i) is lawfully resident on the reserve; or
- (ii) has applied for membership in the band and, in the judgment of the Band Council, has a significant commitment to, and knowledge of, the history, customs, traditions, culture and communal life of the Band and a character and lifestyle that would not cause his or her admission to membership in the Band to be detrimental to the future welfare or advancement of the Band;
- (b) a natural child of parents both of whose names are entered on the Band List:
 - (c) with the consent of the Band Council, any person who
 - (i) has applied for membership in the Band;
- (ii) is entitled to be registered in the Indian Register pursuant to the Act;
 - (iii) is the spouse of a member of the Band, and

- (iv) is not a member of another band;
- (d) with the consent of the Band Council, any person who
 - (i) has applied for membership in the Band,
- (ii) was born after the date these rules come into force, and
- (iii) is the natural child of a member of the Band, and
- (e) any member of another band admitted into membership of the Band with the consent of the council of both bands and who thereupon ceases to be a member of the other band.
- 4. For the purpose of section 3(a)(i) and section 6 the question whether a person is lawfully resident on the reserve shall be determined exclusively by reference to by-laws made by the Band Council pursuant to section 81 of the Act except that, at any time when there are no such applicable by-laws in force, no person shall be considered to be lawfully resident on the reserve for the purpose of section 3(a)(i) and section 6 unless the residence of such person on the reserve has been approved or ratified by a resolution of the Band Council that is expressed to be made for the purpose of these Rules.
- 5. In considering an application under section 3, the Band Council shall not refuse to enter the name of the applicant in the Band List by reason only of a situation that existed or an action that was taken before these Rules came into force.
- 6. The Band Council may at any time delete from the Band List the name of any person who has applied to the Band Council to have his or her name deleted from the Band List or the name of any person who is not then lawfully resident on the reserve and who, in the judgment of the Band Council, either does not have a significant commitment to the history, customs, traditions, culture and communal life of the Band or has a character or lifestyle that would cause his or her continued membership in the Band to be seriously detrimental to the future welfare or advancement of the Band; provided that, before a decision to delete the name of any person from the Band List is made under this section, otherwise than pursuant to an application by such person, the Band Council shall give fifteen days notice to such person who shall then be entitled to make representations to the Band Council in writing, in person or through an agent or counsel within such period of fifteen days.

- 7. Where the name of a person is deleted from the Band List pursuant to section 6, the names of his or her minor children may, in the discretion of the Band Council, also be deleted from the Band List.
- 8. Notwithstanding section 6 the Band Council shall delete from the Band List the name of any person who has been admitted into membership of another band with the consent of both the Band Council and the admitting band.
- 9. Except as otherwise expressly provided in these Rules, no application shall be required before the Band Council may enter in the Band List the name of any person who has a right to have his or her name entered in the Band List pursuant to these Rules.
- 10. Where, pursuant to section 3 of these Rules, an application is required before a person has a right to have his or her name entered in the Band List, such application may be made in such manner and form as the Band Council may determine from time to time and, for greater certainty, the Band Council may permit applications to be made under section 3(d) by a parent or guardian of a natural child referred to therein who is an infant at the time the application is made.
- 11. The Band Council may consider and deal with applications made pursuant to section 3 of these Rules according to such procedure and at such time or times as it shall determine in its discretion and, without detracting from the generality of the foregoing, the Band Council may conduct such interviews, require such evidence and may deal with any two or more of such applications separately or together as it shall determine in its discretion.
- 12. Any person whose application for membership in the Band pursuant to section 3 of these Rules has been denied, or whose name has been deleted from the Band List pursuant to section 6, by the Band Council may appeal such decision to the electors of the Band by delivering notice in writing to the Band Council at the office of the Band within 15 days after communication to him or her of the decision of the Band Council.
- 13. Within 60 days after receipt of a notice of appeal pursuant to section 12 of these Rules the Band Council shall convene a meeting of the electors of the Band for the purpose of disposing of the appeal and the applicant shall be entitled to be present at such meeting and make representations thereto in person or through an agent or counsel.
- 14. Each discretionary power conferred upon the Band Council under these rules shall be exercised by the Band Council in good faith, without discrimination on the basis of sex and in accordance with its judgment of the best interests and welfare of the Band.
- 15. No person shall have a right to have his or her name entered in the Band List except as provided in section 3 of these Rules.



This will be a supplementary benefit, that is, beneficiaries must first take advantage of other benefits available through government, First Nation programs, and health insurance programs.

Sawridge Trusts benefits are only available as long as the Trusts have the resources to support these benefits.

Addictions Treatment Support Benefit

The Sawridge Trusts have established a limited annual fund to cover the costs of beneficiaries and their dependants attending authorised alcohol and drug treatment programs.

Eligible treatment programs will include accredited programs provided by reputable professionals with a proven record of success in treating addictions.

Priority will be given first to certified treatment programs first in the Province of residence of the beneficiary; second to certified treatment programs within Canada; third to certified treatment programs with North America.

Only in special circumstances will consideration be gradified transfer on the gradient of the second of the second

America and only then with the approval of the Trustees.

Available Funding

Because funding is limited each year, funding will be made available on a **first-come-first-serve basis**. Decisions will be governed by the total funding provided by other funding agencies and by the commitment of the individual to a treatment regime.

Who is Eligible

For the purposes of this benefit, an eligible beneficiary is any person who has been confirmed by the Board of Trustees of the Sawridge Trusts as a beneficiary under the rules of the Trusts as well as their dependants.

For the purposes of this benefit, an eligible dependant will include any natural child or any child adopted through legal or customary adoption by an eligible beneficiary or a spouse of an eligible beneficiary who is under 25 years of agand who is registered in a full-time or part-time education program with an accredited educational institution.


How to Access the Benefit

Funding for addictions treatment services will only be provided in cases where the beneficiary or dependent has first developed a treatment plan with the Trusts' Administrator and other professionals and has made a commitment to follow through with the full treatment program.

While the Trusts recognize that relapses, in the case of addictions, are possible and even likely, the Trusts will not allow abuses of the Addictions Treatment Fund by beneficiaries who repeatedly relapse and have to attend a new treatment pro-

gram. After the second use of the Fund, every beneficiary application for renewed treatment will require the approval of the Board of Trustone

The Trusts' Administrator is authorized to approve treatment plans and payment for treatment services for the first two applications without having to obtain the approval of the Trustees provided that there remains sufficient funds in the current year's budget for the Addictions Treatment Fund.







Compassionate Care and Death Benefit

Supplementary Benefit

All Sawridge Trusts are supplementary benefits. They are meant to support other benefits provided by Sawridge First Nation, the Federal Government, the Provincial Government and the community. Where another similar benefit exists, it must be accessed first.

Sawridge Trusts benefits are only available as long as the Trusts have the resources to support these benefits.

Compassionate Care Benefit

This benefit provides for travel, meals and accommodation costs for the beneficiary and her/his immediate family in the event of a **serious or life-threatening illness** resulting in hospital confinement or two weeks or more of intense home care of a family member—as defined under **Who is Eligible** section below—of an eligible beneficiary. The maximum amount covered is up to \$6,000 per incident and up to a lifetime maximum of \$60,000.

Travel costs are covered from the home of the eligible beneficiary to the place where the family member is being treated. If hotel accommodation is required for the beneficiary and his family at this location, this cost is also covered. If a Sawridge Inn exists at this location, arrangements will be made for the beneficiary to stay at the Sawridge Inn and costs will be billed directly to the Sawridge Inn and costs will be billed directly to the Commodation will be arranged in hocation, accommodation will be arranged in

other suitably priced hotel accommodations. Costs will be covered only as long as the ill family member is confined to a hospital in a distant location.

Death Benefit

In the event of the **death of a family member**—as defined under **Who is Eligible** section below—the Trusts will assist in covering funeral costs including the cost of the wake, the cost of the funeral, the cost of burial and a headstone and the cost of a reception after the funeral up to a maximum of \$12,000 per incident.

If the person was eligible for the Canada Pension Plan Death Benefit of up to \$2,500, this amount shall be used first. If other sources of funding are available, these will be used first.

Who is Eligible

For the purposes of this benefit, an eligible beneficiary is any person who has been confirmed by the Board of Trustees of the Sawridge Trusts as a beneficiary under the rules of the Trusts.

A family member of an eligible beneficiary includes:

- a child of the beneficiary or of her/his current, co-habiting spouse or common-law partner, the current, co-habiting spouse or common-law partner of the beneficiary;
- the father or mother or his/her partner of either the beneficiary or her/his current cohabiting spouse or common-law partner;
- brothers, sisters, stepbrothers or step sisters of either the beneficiary or her/his current, co-habiting spouse or common-law partner;
- grandparents or step grandparents of either

- the beneficiary or her/his current cohabiting spouse or common-law partner;
- grandchildren or step-grandchildren of either the beneficiary or her/his current, cohabiting spouse or common-law partner; or





Supplementary Benefit

This will be a supplementary benefit, that is, that beneficiaries must first take advantage of other benefits available through government, First Nation programs, student loans and lines-of-credit and scholarship or student bursary programs and through full or part-time employment.

Sawridge Trusts benefits are only available as long as the Trusts have the resources to support these benefits.

Education Support Benefit

The Sawridge Trusts have established a limited annual fund to cover the costs of beneficiaries and their dependants attending authorised post-secondary education programs.

For the purposes of this benefit, eligible education programs include:

- Recognised upgrading programs to improve opportunities for higher education.
- Recognised technical and skills development training programs
- Recognised university programs up to and including doctoral level study but not including post-doctoral studies.

If the individual receives maximum funding available through federal government grants or other scholarship programs or if the individual is able to personally fund her/his education through parental contributions or self-employment, this person will not be placed as high in priority as someone who has no financial support programs available to them.

Funding will also be accorded in priority to those with high academic performance records.

Who is Eligible

Successful applicants will be required to provide on-going proof of enrolment, attendance and academic performance in order to be considered for on-going financial support from the Trusts.



The benefit only covers those persons who are regularly employed but who are not covered for sick leave by their employer or by Employment Insurance Sick Benefits and who have no other source of income during times of illness.

Benefits will be paid upon submission of receipts for expenditures or by payment of invoices from the supplier up to the maximum amount under the benefit.





Special Rates at Sawridge Inns for Beneficiaries



Privilege Not A Benefit

As opposed to other benefits provided by the Trusts, the special rates provided to Sawridge trusts beneficiaries by the Sawridge Inns and Conference Centres is not funded directly by the Trusts. These special rates are a privilege provided to the beneficiaries by the Sawridge Inns, which are wholly owned by the Trusts, through a special arrangement between the Trustees and the Directors of the Sawridge Group of Companies.

Limitation

Special rates can only be provided when there is a surplus of rooms available at one of the Sawridge Inns. The Inns are in business to make profit that will help to fund benefits for all beneficiaries. The special room rates can only be provided if they do not affect the profitability of the Inn. If there is a shortage of rooms and if a paying customer will pay full rate for a room rather than the discounted rate being paid by the beneficiary, the special rate will not be available for a beneficiary for that particular time period.

Who is Eligible

For the purposes of this privilege, an eligible beneficiary is any person who has been confirmed by the Board of Trustees of the Sawridge Trusts as a beneficiary under the rules of the Trusts. Definition of the Service

Provided that rooms are available and that occupancy rates are below 85%, the Sawridge Inns will provide a discounted room rate of \$69 per night plus applicable taxes up to a maximum of two rooms per beneficiary.

In addition to the room, the room guests will be provided discounted meal price rates of 50% ONLY WHILE THEY ARE REGISTERED AT THE INN. This discounted rate does not apply to alcohol, tobacco products, gratuities and taxes. Discounts are available only from Sawridge owned and operated services and not from private contractors providing service at Sawridge facilities. The beneficiary must present the discount coupon provided at registration in order to access the meal discounted rate.

How to Access the Benefit

Sawridge Trusts beneficiaries can access this discounted room and meal rate by contacting the Trusts Administrator at the Sawridge Trusts office at 1-888-988-7723 or by contacting the Chief or administrator at the Sawridge First Nation office in Slave Lake at 1-780-849-4331.

The room must be reserved up to 60 days from the date of the planned trip. Once you are informed that the room is available, you will have to call the Sawridge Inn in question to actually reserve the room and hold the reservation with a valid credit card number. If the room is being obtained through the Compassionate Care and Death Benefit, the Trusts may guarantee the room by having the bill sent directly to the trust office rather than having the beneficiary pay at the end of the stay. In this case, a credit card may not be required.

Credit Card Requirement

In order to hold a room reservation at any hotel, the person making the booking must guarantee the room using a valid credit card. Until the room and meal bill is finally paid, the credit card will be used to guarantee that payment will be made. Without a valid credit card to hold the reservation, the room cannot be booked.

If you do not show up when you have booked a room and fail to call the Sawridge Inn concerned to inform them that you are cancelling the reservation, your credit card may still be charged for the room.

Respect and Good Behaviour

Even though the Sawridge Inns are closely associated with the Sawridge Trusts, beneficiaries making use of services at the Inns are expected to treat the staff and other patrons with respect. The hotel is entitled to evict a guest that is unruly, abusive toward staff and other patrons, smoking in a non-smoking room or is causing damage to the facilities.

If you have a complaint about service that you receive at the Sawridge Inn, ask to speak to the Front Desk or General Manager to resolve your problem. If you are still not satisfied, contact the Trusts Administrator or the Chief or administrator at the Sawridge First Nation Office to address your complaint with them.







It covers health care costs like hospital, ambulance, chiropractors, physiotherapists, speech therapists, psychologists/social workers, hearings spids penprostheses, wheelchair

ramps and glucose monitoring equipment. It also covers basic/major/orthodontic dental care, prescriptions and out-of-country emergency medical care.

Life Insurance

The life insurance will provide \$250,000 of fully-paid, permanent life insurance



for each beneficiary between 18 and 60 years of age. This insurance will pay out \$200,000 to the person designated by the beneficiary and \$50,000 to the Trust to fund future life





Supplementary Benefit

All Sawridge Trusts are supplementary benefits. They are meant to support other benefits provided by Sawridge First Nation, the Federal Government, the Provincial Government and the community. Where another similar benefit exists, it must be accessed first.

Sawridge Trusts benefits are only available as long as the Trusts have the resources to support these benefits.

The Benefit

The Sawridge Trusts have established a "One Time Only Good Faith Cash Disbursement" to be made to each of the identified and approved adult beneficiaries of either Trust.

A single cash disbursement of \$2,500 will be to each adult beneficiary who is 18 years of age and older.

Only one payment of \$2,500 will be made to each beneficiary for this benefit regardless of whether the beneficiary is a member of one or both Trusts.

age will not be eligible for this benefit until they reach the age of 18 years of age and apply. Payments will be honoured automatically when these beneficiaries reach the age of majority, subject to available funds.

Payments to newly identified beneficiaries will be made as soon as that beneficiary has been authorized by the Board of Trustees and registered with the Trusts' Office.

While other cash disbursements may be made available to beneficiaries in the future, it is not the intent of the Trusts to make regular cash disbursements at this time.

Who is Eligible

For the purposes of this benefit, an eligible beneficiary is any person who has been confirmed by the Board of Trustees of the Sawridge Trusts as a beneficiary under the rules of the Trusts and who has attained the age of 18 years.

How to Access the Benefit

Beneficiaries do not need to do anything



to receive this benefit. It will be issued automatically by the Trusts' Office.

An application will be made to amend the Sawridge Band Trust to allow increased terms for the Trustees. Under the proposal, the Chief will have a term of six (6) years, one Councillor will have a term of four (4) years and the other Councillor will have a term of two (2) years. They would not be replaced until the end of their terms as trustees even if they were defeated in an election. The Trustees Act requires the consent of the adult beneficiaries. The Court can consent for Minors.

Whereas the Settlor is Chief of the Sawridge Indian Band No. 19, and in that capacity has taken title to certain properties on trust for the present and future members of the Sawridge Indian Band No. 19 (herein called the "Band"); and,

Whereas it is desirable to provide greater detail for both the terms of the trust and the administration thereof; and,

Whereas it is likely that further assets will be acquired on trust for the present and future members of the Band, and it is desirable that the same trust apply to all such assets; 50-Minutes, Sawridge Band Trust, Trustees Meeting, Signed Executed copy from lawye file, 8206.pdf

NOW, therefore, in consideration of the premises and mutual promises contained herein, the Settlor and each of the Trustees do hereby covenant and agree as follows:

- 1. The Settlor and Trustees hereby establish a Trust Fund, which the Trustees shall administer in accordance with the terms of this Agreement.
- 2. Wherever the term "Trust Fund" is used in this Agreement, it shall mean:
 - (a) the property or sums of money paid, transferred or conveyed to the Trustees or otherwise acquired by the Trustees including properties substituted therefore, and
 - (b) all income received and capital gains made thereon, less,
 - (c) all expenses incurred and capital losses sustained thereon and less,
 - (d) distributions properly made therefrom by the Trustees.
- 3. The Trustees shall hold the Trust Fund in trust and shall deal with it in accordance with the terms and conditions of this Agreement. No part of the Trust Fund shall be used for or diverted to purposes other than those purposes set out herein.
- 4. The name of the Trust Fund shall be "The Sawridge Band Trust", and the meetings of the Trustees shall take place at the Sawridge Band Administration Office located on the Sawridge Band Reserve.
- 5. The Trustees of the Trust Fund shall be the Chief and Councillors of the Band on the effective date of this Agreement (as duly elected pursuant to Sections 74 through 80 inclusive of the Indian Act, R.S.C. 1970, c. 1-6 as amended from time to time). The Chief shall serve a term of Six (6) years as Trustees.

One Councillor (to be determined by a majority of the Three Trustees) shall serve Four (4) years as Trustee. The other Councillor shall serve a term of Two (2) years as Trustee. completion of their respective terms as Trustees, the Trustees shall resign as Trustee. If the Trustee whose term has ended was Chief when appointed Trustee, he shall automatically be replaced as Trustee by the new Chief for a term of Six (6) years. Trustee whose term has ended was a Councillor, he shall be replaced as Trustee by one of the new Councillors (to be determined by a majority of the Chief and Councillors at that time). In the event that an elected Chief or Councillor refuses to accept the terms of this trust and to act as a Trustee hereunder, the remaining Trustees shall appoint a person registered under the Indian Act as a replacement for the said recusant Chief or Councillor, which replacement shall serve for the remainder of the term of the recusant Chief or Councillors. In the event that the number of elected Councillors is increased, the number of Trustees shall also be increased. In the event that there are no Trustees able to act, any person interested in the Trust may apply to a Judge of the Court of Queen's Bench of Alberta who is hereby empowered to appoint one or more Trustees, who shall be a member of the Band.

6. The Trustees shall hold the Trust Fund for the benefit of all members, present and future, of the Band; provided, however, that at the end of Twenty One (21) years after the death of the last descendant now living of the original signators of Treaty Number 8 who at the date hereof are registered Indians, all of the Trust Fund then remaining in the hands of the Trustees shall be divided equally among all members of the Band then living.

Provided, however, that the Trustees shall be specifically entitled not to grant any benefit during the duration of the Trust or at the end thereof to any illegitimate children of Indian women, even though that child or those children may be registered under the Indian Act and their status may not have been protested under Section 12(2) thereunder; and provided further that the Trustees shall exclude any member of the Band who transfers to another Indian Band, or has become enfranchised (within the

The Trustees shall have complete and unfettered discretion to pay or apply all or so much of the net income of the Trust Fund, if any, or to accumulate the same or any portion thereof, and all or so much of the capital of the Trust Fund as they in their unfettered discretion from time to time deem appropriate for the beneficiaries set out above; and the Trustees may make such payments at such time, and from time to time, and in such manner as the Trustees in their uncontrolled discretion deem appropriate.

- 7. The Trustees may invest and reinvest all or any part of the Trust Fund in any investment authorized for Trustees' investments by the Trustees' Act, being Chapter 373 of the Revised Statutes of Alberta, 1970, as amended from time to time, but the Trustees are not restricted to such Trustee Investments but may invest in any investment which they in their uncontrolled discretion think fit, and are further not bound to make any investment nor to accumulate the income of the Trust Fund, and may instead, if they in their uncontrolled discretion from time to time deem it appropriate, and for such period or periods of time as they see fit, keep the Trust Fund or any part of it deposited in a bank to which the Bank Act or the Quebec Savings Bank Act applies.
- 8. The Trustees are authorized and empowered to do all acts necessary or desirable to give effect to the trust purposes set out above, and to discharge their obligations thereunder other than acts done or omitted to be done by them in bad faith or in gross negligence, including, without limiting the generality of the foregoing, the power
 - (a) to exercise all voting and other rights in respect of any stocks, bonds, property or other investments of the Trust Fund;
 - (b) to sell or otherwise dispose of any property held by them in the Trust Fund and to acquire other property in substitution therefore; and

- (c) to employ professional advisors and agents and to retain and act upon the advised given by such professionals and to pay such professionals such fees or other remuneration as the Trustees in their uncontrolled discretion from time to time deem appropriate (and this provision shall apply to the payment of professional fees to any Trustee who renders professional services to the Trustees).
- 9. Administration costs and expenses of or in connection with the Trust shall be paid from the Trust Fund, including, without limiting the generality of the foregoing, reasonable reimbursement to the Trustees or any of them for costs (and reasonable fees for their services as Trustees) incurred in the administration of the Trust and for taxes of any nature whatsoever which may be levied or assessed by Federal, Provincial or other governmental authority upon or in respect of the income or capital of the Trust Fund.
- 10. The Trustees shall keep accounts in an acceptable manner of all receipts, disbursements, investments, and other transactions in the administration of the Trust.
- 11. The Trustees shall not be liable for any act or omission done or made in the exercise of any power, authority or discretion given to them by this Agreement provided such act or omission is done or made in good faith; nor shall they be liable to make good any loss or diminution in value of the Trust Fund not caused by their gross negligence or bad faith; and all persons claiming any beneficial interest in the Trust Fund shall be deemed to take notice of and subject to this clause.
- 12. A majority of the Trustees shall be required for any action taken on behalf of the Trust. In the event that there is a tie vote of the Trustees voting, the Chief shall have a second and casting vote.

Each of this Trustees, by joining in the execution of this Trust Agreement, signifies his acceptance of the Trust herein.

Any Chief or Councillor or any other person who becomes a Trustee under paragraph 5 above shall signify his acceptance of the Trust herein by executing this Trust Agreement or a true copy hereof, and shall be bound by it in the same manner as if he or she had executed the original Trust Agreement.
