The information you included was to determine if you did now or would in the future qualify as a current member according to the rules—whichever set applies.

From what I understand, you enfranchised of 15 July 1988 and received your share of the assets of the First Nation at the time amounting to \$244,128.67. Only current beneficiaries of the Trusts are entitled to any Trust assets and only at the time of distribution. The Trust is not distributing cash assets but is providing benefits (education, health, etc.) to beneficiaries as they are needed.

If you wanted to be included in the list of current beneficiaries, you would have to apply for membership and be accepted.

John,

According to the current definition of beneficiaries, beneficiaries have to be persons who would have qualified as Band members under the Indian Act 1970. That includes the non-member spouses of male members and the children of male members and married female members. Basically, a person would have to be a current member, married to a current member or a child of a current member. The proposal before the Court is to change the 1985 Trust definition to be the same as the 1986 Trust definition, that is, simply a current member under the Membership Rules of the First Nation without reference to the Indian Act 1970. In both the current and the proposed definitions, you have to be a member of the First Nation under the rules which exist at the time.

If Aboriginal Affairs sent you a letter reinstating your treaty status, this does not give you band membership, only treaty status. You have to apply to the First Nation for band membership.

If you are referring to the letter we asked the Minister to send out to all those with treaty status and a 454 number but not band membership, this was simply to notify you of the court action.

Neither letter has any effect either on your status as a beneficiary or as a Band member.

Peggy,

If you married a Band member to achieve status, you must provide a copy of your marriage license. You don't need to provide and ancestral information unless it relates to your status as a Band member. If you are no longer married to the Band member, you need to detail whether the separation was through divorce, separation or death. In your son, Nathan's case, he should detail his paternal ancestors since those contribute to his status as a Band member. His maternal ancestors, though illustrious, do not contribute to his status. If he is missing his paternal lineage information, tell him to fill out what he can and we will try to track down the missing information. Hope this helps,

Hi, Paul. I received the beneficiary application form in the mail just last week in addition to the form you attached to your e-mail. I am in the process of filling it out and I have several questions. I became a member of Sawridge Indian Band No. 454 through marriage to a band member in 1981. Prior to that I was neither status nor a Band member. In fact, I was born in the United States (Illinois). Questions: (1) how would I answer the question in the middle of the front page: "Are you descended from, married to or adopted by one of the original Sawridge Treaty 8 signatories-Yes or No" when I was but am no longer married to a Sawridge band member? i.e., is it a Yes or No response? (2) With regard to the back side of the application form, is it necessary to fill in Parents Information and Grandparents Information. All of these deceased ancestors of mine are American and non-status/non-aboriginal. Is the information necessary? If not, should it be left blank or should I just fill in NA (for not applicable)? (3) with regard to my son, Nathan Ward, would he need to fill out Maternal Grandparents since those would be my American, non-status/non aboriginal parents? (4) If my son lacks the information for Paternal Grandparents, what should he fill in? Please advise. Thank you.

Floyd,

In case you did not receive the application form that was mailed out to beneficiary applicants, I am enclosing the forms and a letter for you. Please return the form to me as soon as possible.

As far as I understand, the Inter-Vivos Trust was set up at a time when Bill C-31 was being considered. This provision was meant to exclude anyone who was not qualified to be a Band member as of April 1982—prior to Bill C-31. However, it may not be as simple as that so we are having a team of lawyers look at the Trust and the law to determine what rules actually apply. That is why we need applications from those who are not clearly Band members.

The Sawridge Band and the Sawridge Trusts do not have anything to do with one another. The Trusts are independent from the Band.

The Trusts are not declaring a 'settlement' to potential beneficiaries. They are trying to identify who is and is not a beneficiary so that benefits programs that are being put in place can begin paying benefits to legitimate beneficiaries.

By the paperwork I sent you, I presume that you are referring to the Application for Potential Beneficiaries. In January of this year, I also sent out a letter to everyone who had filled out one of those applications telling them that if they wished to be considered as a beneficiary that they had to apply for Indian Status through Indian Affairs (if they hadn't done so already) and that they had to apply for membership in the Sawridge First Nation. If you haven't done that, I would suggest that you do so.

The Court process that is now underway is to get the Court's advice and direction concerning the identification of beneficiaries to the 1985 Trust. The beneficiaries to the 1986 Trust are already identified as the members of Sawridge First Nation.

The Trusts do not have individual trust funds set aside for any individual beneficiary so there would not be a fund set aside for you since, at this time, you are not one of the identified beneficiaries. Even if you were a beneficiary, there are no funds to be handed out to anyone. The Trust was set up to provide benefits and to invest money for the beneficiaries from First Nation oil revenues in the 1980s. At present, the Trusts provide health and life insurance, compassionate care, seniors support, personal development and education support benefits but no cash payments.

In response to your memorandum dated on April 7, 2010, I would like to inform you of my reason why I have not responded by filling out the Beneficiary Application Form.

In April 2004, I received a telephone call at home from Catherine M. Twinn. She informed me that I was no longer a beneficiary because of my marriage to Richard Darrel Vincent. Apparently, according to the rules of eligibility for beneficiary status as stated to me by Catherine, I forfeited my status of a beneficiary of the trusts because I married a non-Indian status person. I'm not sure if Catherine had the authorization by the rest of the trustees to act in such a manner that has caused me pain and confusion. I have not received any written notice from the trustees that this decision has been made so have no reason to believe I forfeited anything.

I am a member of the Sawridge Band. I have never ceased to be a member of the Sawridge Band. I have not acquired my band membership by any other means other than being born into the Sawridge Band. I have kept my family name. I have been both a contributor to the Band and to the Group of Companies. ALL of the trustees know who I am. If I'm not a beneficiary, then who is?

Also, the trusts were created to protect the assets of the Sawridge Band should the band experience an influx of NEW members who may wish to liquidate these assets. From my understanding from conversations with my father, Walter P. Twinn, one trust considers all band members on today's list to be beneficiaries while the other trust considers the band members who were on the band list at the time that trust was written to be beneficiaries. Either way, I am on both lists and consider myself a beneficiary and have no need to fill out the application form.

In my opinion, it is not fair that the trustees are requiring the members who never ceased to be a member or have not acquired membership through any other means but by being born into the band to fill out an application. These beneficiaries existed before the appointment of the current trustees and their rules. I think the burden of proof that I am NOT a beneficiary belongs to the trustees and not on the basis that I have rejected the application processes for those of us who have always been on band list and therefore always been a beneficiary.

Based on extensive legal advice and negotiations with the Sawridge First Nation, the Sawridge Trusts Trustees have come to the conclusion that the provisions of the two trust documents envision that all beneficiaries of the Trusts must be Band members and that the only body able to make a determination as to who qualifies as a Band member is the Sawridge First Nation through its Chief and Council, Membership Committee and Legislative Assembly using the Membership Code established by the Sawridge First Nation.

As such, the Sawridge Trusts have decided to abandon their previous decision to appoint a tribunal to review the applications you and other persons submitted to the Trusts to be considered as beneficiaries in favour of having the Membership Committee of the Sawridge First Nation make a determination of who qualifies to be a member of the First Nation.

The definition of beneficiaries for the Sawridge Trust of 15 August 1986 is quite clear:

"Beneficiaries" at any particular time shall mean all persons who at that time qualify as members of the Sawridge Indian Band under the laws of Canada in force from time to time including, without restricting the generality of the foregoing, the membership rules and customary laws of the Sawridge Indian Band as the same may exist from time to time to the extent that such membership rules and customary laws are incorporated into, or recognized by, the laws of Canada.

Since the Sawridge First Nation has a Membership Code in force, the Trust definition of a beneficiary to the Sawridge Trust can be taken to mean "anyone who has been accepted as a member of the Sawridge First Nation according to the Membership Code".

The definition of beneficiaries for the Sawridge Intervivos Settlement of 15 April 1985, which reads:

"Beneficiaries" at any particular time shall mean all persons who at that time qualify as members of the Sawridge Indian Band No. 19 pursuant to the provisions of the Indian Act R.S.C. 1970, Chapter 1-6 as such provisions existed on the 15th day of April, 1982 and, in the event that such provisions are amended after the date of the execution

of this Deed all persons who at such particular time would qualify for membership of the Sawridge Indian Band No. 19 pursuant to the said provisions as such provisions existed on the 15th day of April, 1982 and, for greater certainty, no persons who would not qualify as members of the Sawridge Indian Band No. 19 pursuant to the said provisions, as such provisions existed on the 15th day of April, 1982, shall be regarded as "Beneficiaries" for the purpose of this Settlement whether or not such persons become or are at any time considered to be members of the Sawridge Indian Band No. 19 for all or any other purposes by virtue of amendments to the Indian Act R.S.C. 1970, Chapter 1-6 that may come into force at any time after the date of the execution of this Deed or by virtue of any other legislation enacted by the Parliament of Canada or by any province or by virtue of any regulation, Order in Council, treaty or executive act of the Government of Canada or any province or by any other means whatsoever; provided, for greater certainty, that any person who shall become enfranchised, become a member of another Indian band or in any manner voluntarily cease to be a member of the Sawridge Indian Band No 19 under the Indian Act R.S.C. 1970, Chapter 1-6, as amended from time to time, or any consolidation thereof or successor legislation thereto shall thereupon cease to be a Beneficiary for all purposes of this Settlement

is also quite clear that "beneficiaries" are clearly meant to be persons who are members of the Sawridge First Nation except for a select few who qualified as Band members under the 1982 provisions of the Indian Act but may no longer qualify under the current Act. The definition, though, refers to a section of the Indian Act that has since been repealed.

As a result of this reference to a section of the Indian Act that is no longer in force, the Trustees have decided to ask the Alberta Court to provide its advice as to whether or not this definition is still valid. All parties having an interest in this application to the Court will be notified when the application is submitted. The application is not likely to affect the requirement that, for the most part, beneficiaries must also be members of the Sawridge First Nation.

Thank you for your application to be a beneficiary of the Sawridge Trusts. In December 2010, the Trustees made a decision that affects your application. The following information has been sent to all applicants.

Based on extensive legal advice the Trustees of the two Sawridge Trusts have come to the conclusion that the determination of Band membership is a matter solely for the Chief and Council, the Membership Committee, with an appeal on individual cases to the Electors. This affects the way in which the Trustees will in future handle the definition of "beneficiaries" in each trust instrument. The Trustees have also drawn encouragement from discussions they have had to date with the Sawridge First Nation. It is hoped that to mutual advantage the Band and the Trustees can usefully work together. Those are the plans.

The Trustees of the Sawridge Trusts have therefore decided to abandon their previous decision to appoint a tribunal to review the applications you and other persons submitted to the Trustees asking to be considered as beneficiaries of either or both Trusts. Instead the Trustees will await the decisions of the Sawridge First Nation, following the processes the First Nation has set in place, as to who are the members of the First Nation.

The definition of beneficiaries for the Sawridge Trust of 15 August 1986 is quite clear:  
"Beneficiaries" at any particular time shall mean all persons who at that time qualify as members of the Sawridge Indian Band under the laws of Canada in force from time to time including, without restricting the generality of the foregoing, the membership rules and customary laws of the Sawridge Indian Band as the same may exist from time to time to the extent that such membership rules and customary laws are incorporated into, or recognized by, the laws of Canada.

Since the Sawridge First Nation has a Membership Code in force, the Trust definition of a beneficiary to the Sawridge Trust can be taken to mean "anyone who has been accepted as a member of the Sawridge First Nation according to the Membership Code".

The definition of beneficiaries for the Sawridge Intervivos Settlement of 15 April 1985, which reads:  
"Beneficiaries" at any particular time shall mean all persons who at

that time qualify as members of the Sawridge Indian Band No. 19 pursuant to the provisions of the Indian Act R.S.C. 1970, Chapter 1-6 as such provisions existed on the 15th day of April, 1982 and, in the event that such provisions are amended after the date of the execution of this Deed all persons who at such particular time would qualify for membership of the Sawridge Indian Band No. 19 pursuant to the said provisions as such provisions existed on the 15th day of April, 1982 and, for greater certainty, no persons who would not qualify as members of the Sawridge Indian Band No. 19 pursuant to the said provisions, as such provisions existed on the 15th day of April, 1982, shall be regarded as "Beneficiaries" for the purpose of this Settlement whether or not such persons become or are at any time considered to be members of the Sawridge Indian Band No. 19 for all or any other purposes by virtue of amendments to the Indian Act R.S.C. 1970, Chapter 1-6 that may come into force at any time after the date of the execution of this Deed or by virtue of any other legislation enacted by the Parliament of Canada or by any province or by virtue of any regulation, Order in Council, treaty or executive act of the Government of Canada or any province or by any other means whatsoever; provided, for greater certainty, that any person who shall become enfranchised, become a member of another Indian band or in any manner voluntarily cease to be a member of the Sawridge Indian Band No 19 under the Indian Act R.S.C. 1970, Chapter 1-6, as amended from time to time, or any consolidation thereof or successor legislation thereto shall thereupon cease to be a Beneficiary for all purposes of this Settlement

is also quite clear that "beneficiaries" are clearly meant to be persons who are members of the Sawridge First Nation except for a select few who did not qualify as Band members under the 1982 provisions of the Indian Act but may now qualify under the current Act . The definition, though, refers to a section of the Indian Act that has since been repealed.

As a result of this reference to a section of the Indian Act that is no longer in force, the Trustees have decided to ask the Alberta Court to provide its advice as to whether or not this definition is still valid. All parties having an interest in this application to the Court will be notified when the application is submitted.
