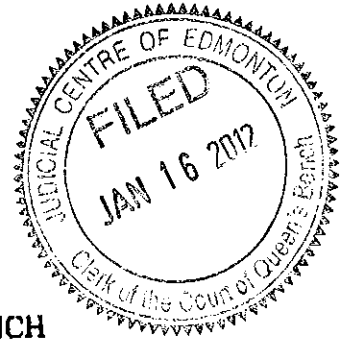



I, Aline Elizabeth Huzar, of Prince George, B.C. SWEAR THAT:


1. This Affidavit is made pursuant to Rule 5.28 of the Alberta *Rules of Court*, and to answer the Written Questions of the Applicants.
2. These answers relate to my Affidavit sworn on November 30, 2011 in the within Proceedings.
3. Under the *Federal Courts Rules*, Rule 334.39, no costs can be awarded for a proceeding such as Federal Court T-1529-95 attached to your Written Questions therefore in answer to question 3 and 4, I state that I along with many others am a Plaintiff in a Class Action in the Federal Court. In answer to Question 5, no order can be granted to compel payment of these costs in this proceeding now a class proceeding under the *Federal Courts Rules*.
4. On December 7, 2011, I received a letter from Chief Roland Twinn and Council which denied my membership in the Sawridge First Nation and on December 19, 2011 I appealed this decision in writing. This decision is contrary to the *Constitution Act, 1982*, sections 35 and 15 and not saved by section 25.
