The purpose of this letter is to inquire whether the parties may be interested in scheduling the appeals for hearing now and setting a timetable for the appeal record and factums.

A timetable provides the parties an opportunity to propose agreed upon deadlines for the filing of all materials instead of following the deadlines set by the *Rules of Court*. It also permits the appeals to be scheduled for hearing in advance (as soon as a notice of appeal is filed), and before all factums are filed.

Should this be of interest to the parties, please submit a proposed timetable that includes filing deadlines for the appeal record and factums and which also includes one or more proposed hearing dates. When submitting a request for a timetable, please keep these parameters in mind:

1. Hearing dates are available on the Court of Appeal's website under Registry > Court Calendar or by clicking [here](#). Ensure that you are looking at Edmonton dates.
2. The deadline for the last respondent factum must be at least:
  - a. 8 weeks before the hearing date in the case of a standard appeal, or
  - b. 2 weeks before the hearing date in the case of a fast track appeal.
