**Re: In the Matter of the *Trustee Act* R.S.A. 2000, c. T-8, as Amended and in the Matter of the Sawridge Bant *Inter Vivos* Settlement created by Chief Walter Patrick Twinn, of the Sawridge Indian Band, No. 19 now known as Sawridge First Nation on April 15, 1985
Appeal No. 2503 0193AC**

We advise and confirm that, together with Janet Hutchison of Hutchison Law, we represent the Respondent Office of the Public Guardian and Trustee in the above referenced appeal.

We write with respect to the Leave to Intervene Application of the Sawridge First Nation Scheduled to be heard (virtually) before a single Appeal Judge on November 26, 2025, at 9:30AM.

As per the Electronic Hearing Attendance Undertaking Form filed with the Court on November 14, 2025, and due to the unavailability of our Mr. Faulds KC and of Ms. Hutchison, the writer alone will be attending the application on behalf of our client.

The Sawridge First Nation indicates in its Memorandum of Argument in support of its application (filed November 7, 2025) that it “will not widen the appeal, nor unduly delay the proceedings, and will confine its submissions to the issues before this Honourable Court”.

On this basis, and subject to appropriate factum limits and speaking time (as well as confirmation they will not seek to introduce new evidence in the appeal), our client consents to Intervenor status being granted to the Sawridge First Nation.

As such, and as per prior related exchanges, with this letter we will not be filing a Memorandum of Argument in response to their application, but we may, as the court may allow, speak to appropriate conditions on the Intervention.
