**Re: In the Matter of the *Trustee Act* R.S.A. 2000, c. T-8, as Amended and in the Matter of the Sawridge Bant *Inter Vivos* Settlement created by Chief Walter Patrick Twinn, of the Sawridge Indian Band, No. 19 now known as Sawridge First Nation on April 15, 1985**  
**Appeal No. 2503 0193AC**

We write in relation to Ms. Twinn's November 17, 2025 request for an extension of time to file the Appellant's factum and increase in factum length.

The OPGT takes no position on Ms. Twinn's request. However, the OPGT ask that if Ms. Twinn's request is granted:

- 1.) The OPGT be granted leave to file its Respondent's factum on January 8, 2026. We are requesting an extension which reflects the 3 days of statutory holidays that arise during the OPGT's one month timeline to file a responding factum in a fast track appeal. We can advise that a filing deadline on the date that our offices reopen from the holiday closure (being January 5, 2026) would be unworkable. The OPGT is not aware of any prejudice that would result from this 3 day extension.
- 2.) The OPGT be granted the same page limit increases as may be granted to Ms. Twinn.
