Thank you for your letter of even date in the above Appeal.

With respect to Justice Woolley's referenced enquiry, we confirm, on behalf of the Respondent Office of the Public Guardian and Trustee, consent to the Intervention subject to appropriate limits and conditions including with respect to factum length.

We did not intend our letter to suggest that the Office of the Public Guardian and Trustee agreed the intervenor should be permitted to file a factum of the same length as the parties. The factum page limits for the parties are currently in a state of flux and thus our reference to seeking to make submissions with respect to limits at the return of the application.

Specifically, the appeal has been categorized as a fast-track appeal which ordinarily limits the parties to a 12-page factum. However, the appellant has requested that the case management officer allow an extension of that to 30 pages, and that request has not yet been ruled on.

As the parties page limits are presently unknown, the submission of the OPGT is that the proposed intervenor be limited to a factum of not more than two-thirds (2/3) of the page limit established for the parties. With respect to oral submissions, we submit these should be limited to 15 minutes for the Intervenor, subject of course to the discretion of the panel.
